- **PRICING - We do it** based on our experience, the quality, and the demand of our customers. You must choose the option to receive 45% _____ of the selling price if paid by check or 55% _____ of the selling price if you choose to be paid as a store credit.
- The supplier asserts legal ownership of all items, free of any liens and encumbrances. The items supplier brings in to sell must be new or like new and freshly cleaned with no stains, nor damage, nor odors.
- **SELECTION** - Items that are discovered to be stained, damaged or flawed after initial brief inspection and acceptance will be sold at a discount, or donated to charity. Please note that we do not contact you in the event this occurs. Inspect your items closely before you bring them here. *There is a \$1 per item charge if we have to steam or spot clean an item.
- **CONSIGNMENT PERIOD** - The merchandise consignment period is 60 days.
- **SALES/PROMOTIONS/MARKDOWNS** - Plums Plus Size reserves the right to discount merchandise during sales events. We reserve the right to progressively mark the items down if necessary to sell.
- **CHECKS** - You may pick up one check at the end of the month after your consignment period ends. Please call first. Checks will be mailed, upon request, for a 50-cent charge. Money earned will stay on your account for one year past the day your items were checked in. After one year any unclaimed money will be forfeited.
- **COME AND GET IT** - We constantly need to make room for new consignment merchandise. If you choose to pick up your unsold items, you must come before your end consignment date is up and you must locate them. If you need assistance, call a day ahead and if an associate assists you in finding any unsold items, a \$1.00 charge will be applied to each item. After your end consignment date, items that have not been sold or picked up by you will become the property of Plums Plus Size.
- **IF SOMETHING DOES NOT SELL** we may donate it to a local charity. You may call & request a receipt for tax purposes for items donated. **PLEASE INITIAL** _____.
- **LIABILITY** - consignee will not hold the **Plums Plus Size Consignment Boutique** liable for any losses due to fire, theft, water damage, and donation or other causes.
- A buyer's fee will be added to the price tag of each item. That fee is passed on to the buyer and will not be reflected on your inventory list.
